No F6(10)SA/DKVIB//2013-14/84 – In exercise of the powers conferred by Section 3 and Section 4 of the Himachal Pradesh Khadi & Village Industries Board Act, 1966 (Himachal Pradesh Act No. 8 of 1966) as extended to the National Capital Territory of Delhi, the Lieutenant Governor of National Capital Territory of Delhi is pleased to appoint Shri Gagan Singh as Chairman of the Delhi Khadi and Village Industries Board, for the development of Khadi & Village Industries in National Capital Territory of Delhi.

It shall come into force on their publication in the Delhi Gazette.

In addition to the functions prescribed in Section 14 of the said Act, the Board will also perform the following functions, namely :-

- (i) To plan, organize and implement the programmes for the development of Khadi and Village Industries coming under purview of Khadi and Village Industries Commission, established under an Act of Parliament.
- (ii) To advise the Government of National Capital Territory of Delhi in the sanction and disbursement of financial assistance to the applicants in accordance with the financial assistance patterns approved by the Khadi and Village Industries Commission.
- (iii) To receive funds from the Khadi and Village Industries Commission or any other source for the implementation of Khadi and Village Industries Programme.
- (iv) To implement Rajiv Gandhi Swavlamban Rozgar Yojna (RGSRY) for the industrial units under House-hold sector and receive funds from the Government of National Capital Territory of Delhi.
